

Supply of Meteorological Data

Permission for visit to technical sections of Reg. Met. Centre, Nagpur is granted and Various meteorological data of Madhya Pradesh, Chhattisgarh and Vidarbha are supplied to Government, Non – Government, scientific, commercial, educational, private etc parties on payment of proper data charge. Requisition letter in organisation’s letter head, to obtain meteorological data may be sent by hand, post, fax or E-mail to this office at following address. Type and details of project, research study etc. should be specified under special information. Letter proforma is attached for reference.

The case of complete data request with all details and necessary required information/documents is taken for process. Based on the request received, the data charges and availability of data is intimated together with format of undertakings on data utilization. GST is levied on total cost (Cost of data + Preparing charges + packing charges of forwarding charges etc.). The rate of GST is as per latest Government directives .

How to pay data charges:

Data charges is to be paid by cash or **DD** of **State Bank of India** in favour of **Assistant Meteorologist (Admin), Regional Meteorological Centre, Nagpur-05**, payable at **main branch (Code No. 0432) Nagpur**. Please note that cheque will not be accepted.

DD of Data charges may also be sent as following:

1. Crossed (A/C Payee) DD for amount of actual cost of data and ,
2. Uncrossed DD for amount of service tax.

On receipt of all the required formalities from the party, the requested and available data are supplied along with the receipt for the data charges deposited.

Registration of Research/Educational organization:

Research/Educational institutes other than those which come under the Ministry of Earth Science should register with **India Meteorological Department** with their specific details of project so that data can be given to them free of cost. In case of supply of the derived products/ reports from basic (observed) data like satellite products, seismic products, Doppler weather Radar products periodical weather reports, wind rose diagrams, design storm parameters, return period analysis, mean data etc., 25% of cost of products/ reports are will be levied from Indian or foreign Institutes. . The registration charges Rs. 5000/- and renewal of registration fee Rs. 1000/- per annum and Service tax additional will be levied. Format of application for registration is attached below.

The research divisions of private / commercial companies / NGOs are NOT eligible for the registration facility. Also, this facility is NOT applicable to those with projects funded by the outside / external departmental agencies, which should be certified accordingly by the Head or the competent authority of their institute.

If institutional research works/ projects are funded by internal (Self) or external bodies like Govt. or others, data will be supplied on a concessional basis by levying the charges as only 5% of data cost.

Students and representatives should submit their authenticity and bonafide certificates from the heads of college/ Institutes to get the data. They should avoid undesirable hoarding of data by individuals.
